Textual Information()	The Company had allotted 7000000 equity shares along with 48500000 warrents and 4166666 along with 15000000 warrents on 30th July, 2019 and 14th August, 2019 respectively. And this has been treated as the physical mode allotment pending for listing, although this had been allotted in Demat form only on the respective dates.
