- 4. Detailed reasons for resignation: The Company has three plant locations requiring travelling to each location as major assets are located there. Due to the current Covid-19 pandemicthe Company's steel plant is closed and the fact that most of the employees have left, we have not been able to travel to plant locations to get the audit started. All these factors are affecting the flow of data and information from the plant which is resulting into inordinate delay in the audit. We have some pre planned commitments and considering the risk due to Covid-19 pandemic weare unable to conduct the Statutory Audit for the Financial Year 2019-20.
- 5. In case of any concerns, efforts made by the auditor prior to resignation(including approaching the Audit Committee/Board of Directors along withthe date of communication made to the Audit Committee/Board of Directors): We have had meetings with the board members and have also communicated the board regarding flow of information.
- 6. In case the information requested by the auditor was not provided, thenfollowing shall be disclosed:
 - a. Whether the inability to obtain sufficient appropriate audit evidence wasdue to a management-imposed limitation or circumstances beyond the control of the management.- Reasons as explained in point 4 above
